## **Product Description**

The PD685/686 Loop Powered Indicators are general purpose loop powered indicators with liquid crystal displays. The equipment is powered from the 4-20mA signal being measured. Connection terminals are provided inside the equipment and the external cable enters the enclosure via conduit or a suitable cable gland.

The electronics assembly is housed in a non-metallic enclosure and the equipment is suitable for both gases and combustible dusts.

Intrinsic safety is achieved by limiting energy storage and discharge, and by connecting to the non-hazardous area via an intrinsically safe interface device.

- i. Under certain extreme circumstances, the non-metallic parts incorporated in the enclosure of this equipment may generate an ignition-capable level of electrostatic charge. Therefore, the equipment shall not be installed in a location where the external conditions are conducive to the build-up of electrostatic charge on such surfaces. This is particularly important if the equipment is installed in a zone 0 location. In addition, the equipment shall only be cleaned with a damp cloth.
- The cable entry into the enclosure shall be by means of conduit or cable gland and shall ii. provide a minimum degree of protection of IP5X.
