



CCS switches are designed to provide long life and maintain excellent set-point accuracy under adverse environmental conditions.

Check Nameplate on the switch for maximum proof (overpressure) or vacuum limits.

GENERAL:



- a) Observe all Warnings and Cautions contained on the attached Warning Sticker, the Warning Declaration and the CCS Catalog.
- b) Follow all applicable Governmental or other Codes or Regulations.
- c) Special Conditions for Safe Use: The integral free lead wires shall be mechanically protected and terminated in a suitable junction or terminal facility.

MOUNTING:

a) Units may be mounted in any position on a flat surface using three 10-32 mounting screws 120° apart on 4.60 inches bolt circle with a clearance for a high pressure port. Or for switches supplied with optional Mounting Bracket on a flat surface using four 10-32 bolts at least 3/8" long on 2" x 2-5/8" inches bolt pattern, see diagram.

WARNING: RELEASE ALL PRESSURE PRIOR TO INSTALLATION OR REMOVAL OF THIS DEVICE. DO NOT EXCEED NAMEPLATE LISTED PROOF PRESSURES.

- a) Units are supplied with female 1/4-18 NPT port(s) suitable for connection to NPT pipe nipples or NPT taper threaded pipe. CCS recommends use of either a union or bendable tubing. This will eliminate excessive strain on the housing.
- b) Pipe joint sealing compound is preferred over Teflon tape. However, either method of sealing is acceptable with proper care to avoid introducing sealing material into pressure.

ELECTRICAL CONNECTIONS:

WARNING: DO NOT MAKE ELECTRICAL CONNECTIONS WHILE ELECTRICAL POWER IS ON. THIS PRODUCT MUST BE INSTALLED BY A QUALIFIED ELECTRICIAN TO AVOID RISK OF ELECTROCUTION.

- a) Electrical conductors are provided within a male conduit connection.
- b) When making wire connections disconnect electrical power. Check for multiple circuits.
- c) Make electrical connections in accordance with the appropriate codes and regulations. Keep as much wire as possible for a service loop to facilitate service, see wiring diagrams.
- d) Proper grounding must be accomplished by use of the illustrated grounding lug (earthing terminal) provided.
- e) CCS recommends that rating for fuses or circuits breakers used for protection against overloads or short conditions should not exceed the maximum ratings of the electrical switch being employed.

ADJUSTMENT: (Not applicable if units are factory set)

Pressure settings are externally adjustable for 675GEY800*, 675DEY800* & 675VEY800* series only.

- a. Unit can be set prior to installation; insert 1/8" Allen wrench into adjustment screw (located in pressure port) and turn clockwise to decrease settings and counterclockwise to increase settings.
- b) If the electrical circuit cannot be used for testing, disconnect electrical power and use a suitable circuit tester or light box.
- c) Reconnect electrical circuit.
- d) Return power to unit.
